Recommendations How can European policymakers help the battery storage sector Battery storage systems are essential for strengthening the EU's energy security and competitiveness by enhancing flexibility, providing ancillary services to secure the grid, maximising the use of renewable energy, and effectively dealing with energy price volatility.

What is the European market outlook for battery storage?

Refers to the European Market Outlook for Battery Storage Solar Power Europe In last year's 'European Market Outlook for Battery Storage 2024-2028' (BESS 2024) report, our Medium Scenario anticipated 22.4 GWh of battery capacity deployed in 2024. The current revision of the actual installation data lands very close to this forecast.

How much battery storage capacity does the EU have?

Narrowing the scope to the European Union (EU), 18.5 GWh of BESS were installed across the bloc in 2024, equivalent to 85% of existing installations on the continent. As a consequence, EU total operating battery storage capacity reached 49.1 GWh at the end of 2024.

What is the European energy storage inventory?

A new interactive platform delivers real-time clean energy storage insights as Europe shifts toward sustainable energy sources. Energy storage helps to balance supply and demand. The European Energy Storage Inventory is the first of its kind at European level to show all forms of clean energy storage solutions.

By 2029, installations are forecasted to grow sixfold to nearly 120 GWh, pushing total capacity to 400 GWh (with 334 GWh in the EU-27). Despite this growth, it remains a small fraction of total energy capacity.
