How can Zambia encourage investment in microgrids?

To incentivise investment in microgrids,Zambia offers financial and regulatory incentives,such as tax breaks on renewable energy equipment imports and reduced corporate taxes for renewable energy investments.

How is energy storage regulated in Zambia?

In Zambia, the legal and regulatory framework for energy storage, including renewable energy storage, is primarily governed by the Energy Regulation Act No 12 of 2019 and the Electricity Act No 11 of 2019. These Acts establish the ERB as the primary regulator, responsible for licensing and setting standards for energy storage activities.

What percentage of Zambians have access to the national power grid?

Only 43 percentof Zambians have access to the national power grid (67 percent of urban residents; and 14.5 percent of rural residents). ZESCO,a vertically integrated parastatal utility,operates government-owned power stations,and is responsible for maintaining and installing transmission lines and distribution networks.
